Taxpayer Advocate Service (TAS)

For clients who are having trouble resolving various tax issues with the Internal Revenue Service. Generally, TAS can help if the client, as a result of the administration of the tax laws:

- Is suffering a significant hardship or is facing an immediate threat of adverse action;
- Will suffer irreparable injury or long-term adverse impact;
- Has experienced a delay of more than 30 days to resolve the issue; or
- Has not received a response or resolution by the date promised.

If the client has an ongoing issue with the IRS that has not been resolved through normal processes, or they have suffered, or are about to suffer a significant hardship as a result of the administration of the tax laws, contact the Taxpayer Advocate Service at 877-777-4778 or in Denver at **303-603-4600**
